Disclosure Materials

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Summary of Issue	Sealand is an apparel company from South Africa that sells clothes using sustainable materials and has one product made from hemp fiber. The company is not involved in the cultivation or harvesting of hemp directly and are not related to any cannabis-derived products that are ingested by humans or used for medical purposes.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	13.6% of the company's revenue is from the sale of the product containing hemp.
Impact on Stakeholders	Cannabis-related products are subject to controversy both because of their current and historic legal status around the world, as well as concerns about the potential harm that the products may cause. Current regulations governing the legality of cannabis-derived products are complex and vary widely by local jurisdiction.
Implemented Management Practices	Sealand Gear is a company registered in South Africa that follows and complies with regulations for the sale of cannabis-related textile products.
