



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	La Consignerie is an online company that sells grocery items that earns a material amount of revenue from the sale of alcohol products.

IMPLEMENTED MGT PRACTICES	The company complies with all the regulations and laws related to the sale of alcohol in the jurisdictions in which it operates. As the company is an e-commerce, the prohibition to buy alcohol for a minor is indicated on the CGV of the site in the part "2.14. Commandes portant sur les boissons alcoolisées" that indicates: In accordance with the terms of article L. 80 of the Code of the drinking establishments and the measures against alcoholism, the sale of alcohol to minors is prohibited. - The User, by accepting the present GTC, guarantees La Consignerie that he/she is over 18 years of age in the event of an Order for any alcoholic beverage, - Any Order placed on behalf of a minor, or in his/her name, and including one or more alcoholic beverages will be refused if La Consignerie is aware of it.
