Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Summary of Issue	Hassell offers design and architecture services to companies in the following industries: Alcohol, Fossil-fuels (other), Gambling, Mining, Pharmaceuticals, Zoos, aquariums, and animal parks. The company has served clients in these industries on an ongoing basis over the last 5 years. In the FY2019 period, Hassell has worked with clients in the Firearms, weapons, munitions sector, but has decided to discontinue working with this industry. The company's services can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	From the company's FY2023 annual revenue: • Clients operating in the Alcohol industry represented 0.21%. • Clients operating in the Gambling industry represented 0.67%. • Clients operating in the Fossil-fuels industry represented 0.52%. • Clients operating in the Mining industry represented 0.44%. • Clients operating in the Pharmaceuticals industry represented 0.53%. • Clients operating in the Zoos, aquariums, and animal parks industry represented 0.33%. The revenue from clients in the Firearms, weapons, munitions industry in FY2019 represented 0.01%.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.



	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Currently Hassell does not have any management practices specifically to mitigate any potential risk related to the controversial industries mentioned above. As for the clients in the Firearms, weapons, munitions sector, the company has decided to discontinue working with this industry.
