



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	As a food manufacturer, the company has many heating process steps that require a natural gas fueled boiler. Their industrial equipment and cold storage (for cheese aging) operate on electric energy.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of the company's revenue come from the creamery.
IMPACT ON STAKEHOLDERS	The company's energy sources are natural gas and electric. As a food manufacturer, they have many heating process steps that require a natural gas fueled boiler. Their industrial equipment and cold storage (for cheese aging) operate on electric energy. Prior to production, the primary contributors to the carbon footprint include the energy/emissions impact of dairy farming, the production of animal feed and product packaging. After production, the primary contributors are the energy/emissions impact of cold supply chain, transportation between storage facilities and direct-to-consumer transportation.
IMPLEMENTED MGT PRACTICES	a) While the company indicates that it is very new to managing the energy and emissions impact, they are starting to measure their energy consumption. Once they establish a benchmark, they can set targets for energy/carbon reduction. b) The company's participation in Dominion Energy's GreenTherm program and Rocky Mountain Power's Blue Sky program demonstrates their commitment to supporting the development of renewable energy and the reduction of greenhouse gas emissions.
