Disclosure Questionnaire Category: Others - Clients in Controversial Industries

Topic	Clients in Controversial Industries
Summary of Issue	Lucha is an equity investment company based in Peru that has partial ownership in a company involved with the medicinal cannabis industry. The company is no longer operational and has been liquidated as a result of a change of regulation regarding the sale of medicinal cannabis products.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Lucha had 45% shares in the company operating in the medicinal cannabis industry, and represented 0% of Lucha's FY2023 revenue.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Lucha does not have a formal position on working with or investing in sensitive industries but shares that their mandate is to work with positive impact companies and stay away from industries that threaten social or environmental well-being. The company conducts a due diligence process on potential investments, involving impact assessment of the company's industry as well as the collection of data from both workers and users of the product or service through interview visits and surveys.
Management Comments	In Peru, patients in need of medicinal cannabis face significant barriers, with over 90% of licensed providers concentrated in the capital. The company, dedicated to overcoming these challenges, aimed to provide nationwide access. By 2022, its efforts had made a substantial impact, successfully reaching patients in 23 out of the 25 regions of Peru.
