

## **DISCLOSURE MATERIALS**

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Digit Business provides some accountancy services related to the payment of taxes, specifically the GST (goods and services tax) and PAYG (pay as you go) reporting, along with superannuation reporting, and payroll tax (state tax). The company's goal is to guarantee that the accounts are completed accurately so that the GST and PAYG being reported are exactly what the business should pay.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	These services account for 100% of the company's revenue. Services include bookkeeping, payroll processing, and advisory.
	Digit Business works mainly with local SMEs (which account for 98% of its clients). The other 2% of its clients are from overseas with a business entity registered in Australia. For these specific clients, Digit Business only provides the accounting software (Xero subscriptions) or looks after the bookkeeping and GST compliance for the local entity.
IMPACT ON STAKEHOLDERS	B Lab recognizes fair payment of taxes as a material business issue and has a Framework for Evaluating Tax Strategies for B Corp Certification. Given Digit Business's limited scope of tax-related services in Australia only, its services are consistent with the principles that (1) the amount of overall taxes paid over time appropriately reflects the actual amount of income generated by the client, and (2) the amount of taxes paid over time in each jurisdiction appropriately reflects the actual operations of the client in that jurisdiction.
IMPLEMENTED MGT PRACTICES	- Digit Business understands that paying taxes is an integral part of a functioning society and as such, the company has an internal policy that determines that for clients who look to avoid paying taxes or work to minimize their taxes, in ways that are unethical, the company can drop these clients and stop supporting them,
	- The company's goal within Australia is to raise the standard of accounting for small businesses. What this looks like in practice is sighting source documents to ensure correct GST treatment, ensuring businesses meet their payroll, superannuation, and GST compliance requirements with the ATO, and supporting them through working with the ATO to provide payment plans for businesses under stress,
	- As BAS agents, they are bound to the BAS agent code of conduct. Within the job descriptions for the accounting team is a direct reference to meeting the BAS agent code of conduct,
	- The company also has internal policies on how to deal with clients who don't meet their compliance obligations.
