Disclosure Materials

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Category: Industries at Risk of Human Rights Violations

Topic	Forced labor, child labor, and human trafficking risks in cocoa/chocolate industry
Summary of Issue	As a chocolate producer, De Bonte Koe operates in an industry in which human rights issues such as forced labor, child labor, and human trafficking are prevalent globally in the cocoa supply chain.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	90% of the company's cocoa comes directly from a cocoa cooperative located in the Dominican Republic, and 10% from farmers located in Ivory Coast and Ghana. This represents approximately 16.3% of the company's supplier annual expenses.
Impact on Stakeholders	The global cocoa industry has a history of forced and child labor, which subjects workers to poor working conditions, low wages, and puts children at risk for human trafficking.
Implemented Management Practices	100% of cocoa sourced by De Bonte Koe is traceable back to the original farmer. The most significant suppliers the company sources from are Fairtrade certified. 90% of cocoa sourced by the company is organic certified and 10% is cocoa horizons certified. To minimize the potential risk of human rights violations the company decided to source from one organic cocoa cooperative located in the Dominican Republic that is considered as the front runner in organic and fairtrade cocoa. The company also has chosen to buy only organic certified beans and work with companies in the supply chain that are organic certified and audited by the European Organic Certifiers Council.
