Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Clients in Controversial Industries
Summary of Issue	TheMerode is a private member's club offering space and facilities for conferences, events, art exhibitions and workspace for its members. The events and conferences hosted are aligned with the club's objective : "to create, stimulate and extend strong links between cultured, committed, influential and open-minded people who wish to discuss and investigate the major societal issues of today and tomorrow, in a prestigious and welcoming setting." The club has a business client from the Fossil-Fuel (coal/oil sands) industry which is deemed controversial by B Lab. The client had bought a membership for some of their staff to have access to TheMerode's infrastructure and programming of conferences & events. The services provided to the clients can be sold to other clients in different industries, including other both non-controversial and controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the fiscal year end of 2023, a total of 0.42% of total revenue was generated through clients in the fossil-fuel industry.
Impact on Stakeholder(s)	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	TheMerode does not specifically target any particular industries. The club's intention has never been to work with clients from sensitive industries and does not actively seek out or prospect any specific industries. TheMerode ensures that the
