Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Category: Industries at Risk of Human Rights Violations

Topic	Forced labor and human rights violations are recognized as material issues in the jewelry industry.
Summary of Issue	B.P. de Silva Jewellers is a Jewellery company that earns a material amount of revenue from raw materials whose supply chain carries risks of human rights violations, which includes jewelry made from precious metals and gemstones.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	100% of B.P. de Silva Jewellers' revenue comes from the sale of jewelry made from precious metals and gemstones. This includes after-sales services.
Impact on Stakeholders	The global jewelry & precious metals industry has a history of forced and child labor, which subjects workers to poor working conditions, low wages, and puts children at risk for human trafficking.
Implemented Management Practices	99% of B.P. de Silva Jewellers' Tier 1 suppliers adhere to a Code of Conduct that includes minimum compliance requirements regarding child labor, forced labor, and conflict minerals, as well as requiring its suppliers to adopt a management system to ensure compliance with the Code. B.P. de Silva Jewellers reviews Code of Conduct compliance and maintenance of relevant certifications (Kimberley Process Certificate and Responsible Jewellery Council Certification) annually.
