Topic	Litigation, Arbitration, and Penalties related to Labor Issues
Summary of Issue	<p>In the past 5 years, CBHI has had 7 Private Attorneys General Act (PAGA) actions filed by former employees. All 7 of these cases are currently pending. Across these complaints, the company is alleged of a mix of the following violations: failure to pay minimum and overtime wages, failure to provide meal periods and rest breaks, failure to provide accurate itemized wage statements and maintain accurate records, failure to timely pay all earned wages and final wages due at the time of separation, failure to reimburse business expenses, failure to provide sick time and vacation pay, waiting time penalties, whistleblower retaliation, wrongful termination, and unfair business practices.</p> <p>Former employees have also filed 12 separate litigation cases involving one or more issues related to discrimination, wage and hour disputes, retaliation, and harassment. Six of these cases were settled through payments by the company that represent <1% of the company's annual revenue. The remaining 6 cases are currently pending.</p> <p>The company has 1 pending case related to a contractor injury. A former contractor nurse practitioner filed a claim against the company for an injury caused by a client.</p> <p>Additionally, CBHI received a regulatory compliance fine from the San Francisco Office of Labor Standards Enforcement (SF OLSE). This fine was issued due to an administrative error in issuing payment to the city for benefit premiums for part-time staff.</p>
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	<p>The size and scope of the PAGA actions involve specific subsets of employees out of the company's total workforce of over 3,000. While the total financial implications are not fully finalized as all seven cases remain pending in active litigation, the company has estimated a potential exposure equal to less than 1% of the company's revenue for one of these PAGA cases.</p> <p>Regarding the standard employment litigation, six cases were</p>



	settled for a total representing less than 1% of the company's annual revenue, while the remaining five cases and the contractor injury claim remain pending. Additionally, the SF OLSE fine was also resolved for an amount representing less than 1% of the company's annual revenue.
Impact on Stakeholder(s)	The primary impacts related to labor litigation are the negative financial impacts and potential violation to workers' rights.
Resolution	All PAGA actions remain pending. Six litigation cases were settled with payment, while the remaining five cases and the contractor injury claim are still pending. The San Francisco OLSE fine has been paid in full.
Implemented Management Practices	<p>In response to one harassment case, the company improved its documentation of the actions taken when management addresses concerns about a client harassing an employee, and to address the San Francisco OLSE fine the company eliminated hiring PT employees in SF to avoid complicated calculations and payments required for PT employees.</p> <p>While many of the company's PAGA cases involve template-based and unfounded allegations, including claims regarding practices that are not applicable to their business, they remain very costly to defend. To help minimize this risk, the company has implemented several proactive compliance measures, including daily attestations and automated penalties, legal review of pay calculations, mandatory manager training, and employee training and attestations regarding workplace practices.</p> <p>No additional management practices have been reported for the remaining cases.</p>
