## **Disclosure Materials**

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Any party may submit a complaint about a current B Corp through B Lab's Public Complaint Process. Grounds for complaint include:

- Intentional misrepresentation of practices, policies, and/or claimed outcomes during the company's certification process
- Breaches of the B Corp Community's core values as expressed in our Declaration of Interdependence

Торіс	Company serves clients in Controversial Industries
Summary of Issue	YSE is a consultancy specializing in recruitment & selection, training & coaching and interim deployment of their own young professionals that has provided its services to clients in the gambling sector. AFA software solutions have been implemented by the company to optimize HR processes for clients in the gambling sector. Their services can also be sold to non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	5.9% of the client revenue has been from clients in the gambling industry during FY2023. The company no longer has clients operating in this industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Starting in 2024, the company has decided to discontinue working with clients in the gambling industry. The company aims to be selective in serving clients in sensitive industries; when evaluating a potential client, the company takes into account the possible impact generated by their services and their services focus on optimizing their clients' HR team and systems.
