



DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Operational on the job fatality
SUMMARY OF ISSUE	The fatality happened during a bus robbery. Our driver was shot by the robbers. Besides our driver, there were no other victims. Police reports were made.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	All passengers were robbed from their personnel belongings (mostly portables).
IMPACT ON STAKEHOLDERS	The value of the belongings in total amounted to 10-15K euro as some of the passengers took the bus in order to go to the bank to make deposits. Baobab Express did not compensate.
RESOLUTION	Our insurance paid a life insurance to the family of our driver.
IMPLEMENTED MGT PRACTICES	Closing the busline in that region. Since, we announced in our rules and procedures that passengers cannot travel with more than 200.000 fcfa. Higher amounts must be declared so that we can take additional security measures.
REPORT	Report by the police. The robbery was reported on radio and television.
