Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Albio is a manufacturer that creates and assembles microbe systems with the most capable microbes that are chosen by analyzing millions of data about their genetics and metabolism, benefiting the agriculture industry. The abuse of agrochemicals deeply affects the micro biodiversity that exists in the soil. Pesticides are used to combat diseases caused by pathogenic microorganisms but they have a reduced vision because they also kill the populations of beneficial microorganisms that are a vital part of the soil ecosystem. On the side chemical fertilizers, being from non-organic sources, produce effects such as salinization where the survival of micro biodiversity becomes increasingly difficult. These are two examples of how common agricultural practices favor the loss of micro biodiversity and therefore the loss of soil fertility.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Approximately 94.6% of Alibio's revenue comes from producing and selling products that create microbe systems
IMPACT ON STAKEHOLDERS	Agriculture poses a risk to local ecosystems of flora and fauna as well as the potential degradation of cultivated land.
IMPLEMENTED MGT PRACTICES	Alibio monitors the behavior of populations of microorganisms through the OMICS, which are techniques and tools that study microbiology through their genetic information. It has been possible to observe how, by working with the AliBio microbial treatment, the beneficial microbiodiversity grows over time, and with a holistic view of the ecosystem, it keeps populations that may have pathogenic behavior at bay.
OTHER MGT COMMENTS	Alibio does not have specific objectives into the preservation of micro biodiversity, the omics studies have a high cost to do it constantly and massively.
