Disclosure Questionnaire Category: Clients in Controversial Industries

Topic	The company works with clients in the following controversial industries: Animal Products/Services, Pharmaceuticals and Fossil Fuels - coal, oil sands.
Summary of Issue	Silly Moose LLC dba KnowledgeOwl is an American software-as-a-service company that provides knowledge base software to companies to clients in the Animal Products/Services, Pharmaceuticals and Fossil Fuels - coal, oil sands industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In 2022, the percentages of the company's revenue generated from services provided to clients in the mentioned industries were: 1. Animal Products/Services: 5.49% 2. Pharmaceutical: 1% 3. Fossil Fuels - coal and oil sands: 3.09%
Impact on Stakeholders	B Lab's view is that companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, B Lab's view is that companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company states that its terms and conditions explicitly grant them the authority to terminate an account for any reason, including behavior deemed harmful by the company. They have implemented a "Policy on Customers in Controversial Industries" which outlines a process for any team member to report a potentially problematic customer. This report is subsequently reviewed by their 'B Corp Committee', and it may result in the termination of the customer's contract. They intend to maintain a list of industries with which they choose not to



	engage as they emerge. Additionally, the company mentions that they have undertaken a review of their top 50 clients based on revenue aiming at identifying any clients associated with controversial industries and all such clients have undergone evaluation by their 'B Corp Committee'.
