



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Company serves and sells alcohol products
SUMMARY OF ISSUE	Lovat Parks is a holiday and residential park operator that earns a material amount of revenue from the sale of alcohol. The company serves alcohol at a bar at Golden Leas (for owners only), and sells alcohol at two shops at Padstow and Green Hill.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 4.3% of the company's revenue was earned from the sale of alcohol
IMPACT ON STAKEHOLDER(S)	Alcohol may have a negative impact on the health and well-being of individuals and their communities
IMPLEMENTED MGT PRACTICES	Lovat Parks complies with all of the regulations and laws related to the sale of alcohol. All premises have licenses authorised by the local councils, and at least 2 members of each park have their own personal licenses to sell alcohol. All employees have in-house training, and the club-house manager and park manager at Golden Leas have food hygiene level 2 certification and follow the 'Perfect Serve' training, which a leading brewery recommends. In terms of over-serving, they are trained to keep an eye on the amount consumed and there is signage in the bar which asks customers to know their limits. If the team think that a customer has over-consumed, they will notify the bar manager and he will authorise that soft drinks only are served. In terms of serving to minors, the company follows the 'Think-25' i.e. anybody who looks under 25 will be asked for ID and there are signs on the wall displaying this. In the park shops, the company must apply to the local councils to be able to sell alcohol. Once approved, the council will issue a license and the company will have a nominated person on the park who must have their personal license. In the shops, the 'Know Your Limit' and 'Think-25' signs are displayed to mitigate any risks of selling to minors.
