This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DATE	Ongoing
TOPIC	Company is a beverage production equipment wholesaler that has clients in the alcohol industry.
SUMMARY OF ISSUE	Scott Laboratories is a North American wholesaler of materials used in the processing, production, and packaging of beverages. Their main clients are in the alcohol industry (eg wineries, breweries, distilleries). They provide products such as yeast, yeast derivatives, bacteria, corks, wirehoods, filtration, equipment and process aids. They do not supply or resell alcohol.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Clients in the alcohol industry account for >95% of annual revenue.
IMPACT ON STAKEHOLDERS	The products that the company sells allows their customers to produce their products within the rules afforded by their jurisdictions. They work with their clients to communicate accepted wine-making practices in both the USA (controlled by the TTB) and Canada (controlled by Health Canada). Their company is not involved in the commercial activities of wineries, and are thus not part of the consumption end of alcohol (where the main harm mitigation is focused). They do work with wineries to develop low or no alcohol alternatives.
IMPLEMENTED MGT PRACTICES	They company also works with clients in the soft beverage and food production, but their primary focus is on solutions for the alcoholic beverage industry. They also have clear drug and alcohol policies for their employees to mitigate harm of nexus/ access to alcoholic beverages.
