This includes partnerships with the Regional Government of Castilla-La Mancha, FSC® Spain, the Polytechnic University of Madrid, the European Design Institute, and the Cuenca City Council, which proudly stands as the second largest forest owner in Europe.

In 2023, Dendron emerged as the **pioneering company** to establish an FSC forest certification group for private owners in Castilla-La Mancha, leading the way in certifying the positive impacts of sustainable forest management on water quality and the preservation of forest carbon stocks within this vibrant community.

Furthermore, she was honored with the **Entrepreneurial Initiative Award** at the 7th Castilla-La Mancha Business Merit Awards.
