Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Summary of Issue	A former employee filed a product liability case in July 2025 alleging that a pump was defective and caused injury. The primary defendant is the pump’s manufacturer, but Bridgetown was named as a co-defendant in order to avoid diversity jurisdiction in federal court.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Financial implication is unknown as the case is pending. Number of individuals affected: 1 (former employee)
Impact on Stakeholder(s)	Injuries sustained by the employee as a result of a defective pump
Resolution	The case is pending
Implemented Management Practices	None reported
Other Management Comments	Bridgetown was named as a plaintiff in order to avoid diversity jurisdiction in federal court and find a more sympathetic jury in state court. The case against Bridgetown is barred by an exclusive remedy of workers' compensation.
