SUMMARY OF ISSUE	Fratelli Guzzini S.p.A. manufactures and sells kitchen accessories and, as a manufacturer that uses energy in its processes, operates in energy intensive industry.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of the company's revenue is earned from the manufacturing and selling of kitchen accessories. Company uses energy from natural gas, electricity from the national grid, and electricity produced by its own photovoltaic plant.
IMPACT ON STAKEHOLDERS	Energy intensive manufacturing activities pose an environmental risk due to the emissions produced by such energy use. The extent of environmental impact is dependent on the energy sources utilized and management practices in place to manage energy use.
IMPLEMENTED MGT PRACTICES	- Fratelli Guzzini has an Environmental Management System that allows the company to track their emissions and energy usage; - Company's carbon index is at 50 (tons per million euros of turnover). The index is 320 if the whole life cycle of their products (upstream and raw materials) is considered; - In order to decrease energy usage and emissions, Fratelli Guzzini has implemented the use of recycled plastics instead of virgin plastic and installed a photovoltaic plant in their factory; - Other practices include the replacement of neon lamps with high-efficiency LEDs combined with presence sensors to optimise their efficiency, installation of inverters on the machinery of the compressed-air station and adoption of a system to regulate the RPM of the hydraulic pumps of the injection moulding machines.
