Topic	Company's Offices
Summary of Issue	The company's office space sits on stilts over the Dunedin Harbour and this harbor is deemed sensitive land for New Zealand Purposes. This land is covered by the Overseas Investment Office of New Zealand.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The company's Dunedin office, hosts 13 workers of its staff (Less than 5% of the company's total workforce). 7% of the company's facilities, in terms of area, are located in/adjacent to a sensitive ecosystem.
Impact on Stakeholders	Having facilities/operations near protected/sensitive ecosystems can potentially impact the flora, fauna and quality of the ecosystem (e.g. noise & light pollution from the facilities, spills, air / soil / water pollution owing to the company's operations). Also, there is a risk of negatively impacting the local communities.
