Summary of Issue	Chengyo Energy offers solar power installation and leasing to its clients and has served clients operating in the Prison industry over the last 5 years, through a subsidiary that has now been sold. The company's services can be offered to both clients in controversial as well as non-controversial industries. Chengyo Energy no longer serves clients in the Prison industry.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Clients operating in the Prison Industry represented 0% of the company's FY2023 revenue, and 1.92% of the company's FY2022 revenue, when the engagement with this industry ended.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards
Implemented Management Practices	will be created to address possible risks related to this matter. Chengyo energy has ceased work with the prison industry and does not plan to engage with this industry in the future. The company has established an exclusion list for industries with high ESG risks and has made this public on their website (see link below). If a client or project meets the following exclusion criteria, they will not undertake the project: (1) Illegal land and buildings. (2) Involving pornographic industry, drug industry, controversial industry Weapons industry, gambling, gaming, illegal products, industries that infringe and violate human rights, nuclear energy or hazardous materials industries.
Report	Chengyo Energy Co ESG
Management Comments	Taiwan does not have privately operated prisons; all prisons are public and fall under the jurisdiction of the Ministry of Justice of the Republic of China (Taiwan). The staff are all civil servants,



and everything operates in compliance with the law without any illegal activities. Our company took on this project precisely because it is a government agency project, although the installation site is located within a prison.
