



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Alpha Inspiration GmbH offers social skills training, consultancy and coaching to help their clients to overcome obstacles. Solving misunderstandings and cultural differences, meanwhile initiating the increase of individual performance.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In 2021, approximately 5% of their revenue came from their client who is in energy industry.
IMPACT ON STAKEHOLDERS	The company doesn't contribute to specific risks and negative impacts related to customers, investors, communities or the environment. The company only help/serve this client just for leadership training.
IMPLEMENTED MGT PRACTICES	Alpha Inspiration's services can be sold and are sold to other non-controversial industries. They are not specifically designed for just one specific industry.
MANAGEMENT COMMENTS	The company acknowledged that they do have a client in the energy industry. This client is EON SE (https://www.eon.de/de/pk.html). It is Germanys largest energy company and Alpha Inspiration only helps them mainly to improve their leadership behaviours by conducting leadership trainings for some of their young high potentials. The approx. revenue with EON was 5% of their overall revenue. This percentage is rather stable over the past 5 years with this one client. And they didn't had other clients in controversial industries.
