Disclosure Questionnaire Category: Other - Clients in Controversial Industries

Topic	Clients in Controversial Industries
Summary of Issue	RecyGlo is a recycling and waste management service provider. The company has had clients in the tobacco industry which is deemed controversial by B Lab. The services offered to the clients in this industry relate to recycling waste and marketing materials. The services provided to the client can be sold to other clients in different industries, including other non-controversial industries
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the fiscal year end of 2023, the company had generated 2.2% of total revenue from clients in the tobacco industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	RecyGlo's last engagement with the client in the tobacco industry was in the year of 2023. The company currently does not have a formal position on working with sensitive industries or a policy to move away from them. Their business engagements are primarily focused on recycling and waste management, without a specific focus on sensitive sectors. RecyGlo has established formal due diligence policies to ensure that its services are utilized in an ethical and environmentally responsible manner. The company conducts comprehensive background checks on all prospective clients to ensure their practices align with the company's commitment to sustainability
