

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

| SUMMARY OF ISSUE | As a linen manufacturing company, Linificio e Canapificio Nazionale operates in an industry that is water intensive. |

| IMPACT ON STAKEHOLDERS | As a water intensive industry, textile manufacturing poses risks such as water stress or depletion of local water sources if water use is not appropriately managed. |
| | Linificio operates in Italy, Lithuania and Tunisia, which are not considered water stressed regions. |
| IMPLEMENTED MGT PRACTICES | Water used for preparing and spinning textile fibres at the Italian Linen Mill comes from a company well subject only to a Single Environmental Authorization (AUA), which the company has obtained. Industrial Waste water flows into the purificiation plant nearby, has 16 discharge points for rainwater and runoff, as well as 1 overflow discharge of the water well storage tanks, which discharge into the Legler Canal, Lombardy region. Due to the type of activity carried out, the Linen Mill in Italy is not subject to regulation related to meteoric waters. The Linificio Linen Mills in Lithuania and Tunisia, derive their water sources entirely from the acqueduct. |
| | The water intensity derived from the production process of the 3 sites is on average 0.13 m3 per kg of yarn (i.e. 130 litres per kg of yarn). Although the company does not have specific water reduction targets, to manage water resources, Linificio continuously monitorns consumption per kg of yarn by implementing recovery cycles and water treatment/purification activities. |
