Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Category: Litigation

Issue Date	April 16, 2025
Topic	Litigation related to Dismissal of a former employee.
Summary of Issue	The company was involved in three litigation cases with employees over unfair dismissal. All the three cases took place in 2022. Two cases were settled, one case found in favour of the company, one case was settled out of court and one case still pending.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The financial impact for all three cases is not significant, likely to be about 0.3% or less of total revenue.
Impact on Stakeholders	The impact is not significant, employees are required to manage part of the workload of the 3 employees dismissed for a short time while replacements were found.
Resolution	1 case was found in the company's favour by the court, the second case was settled out of court for a lesser amount versus what the claimant had wanted. There is still one case pending outcome.
Management Practices	Performance review and feedback have been implemented. In July 2023 we re-organised the company chart to ensure that there is greater transparency and employees have clearer understanding of the various roles and ownerships.
