Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Industries at risk for human rights violations

Topic	Company sources metal precious and gemstones
Summary of Issue	MiaDonna is a jewelry retailer and manufacturer whose products utilize precious metals, lab-grown diamonds and gemstones. These raw materials could be considered conflict minerals and pose a potential human rights risk.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Approximately 100% of the company's revenue comes from jewelry made with precious metals and lab-grown gemstones.
Impact on Stakeholders	The use of precious metals and earth-mined gemstones poses a human rights risk due to the possibility that they are sourced from conflict-affected and high risk areas, where they may be used to finance conflict and/or be associated with human rights abuses in the supply chain.
Implemented Management Practices	MiaDonna has a code of conduct applicable and signed by all their suppliers that establishes minimum expectations regarding social and environmental standards. In addition to that, the company only uses lab-grown diamonds and gemstones in its products. Each lot can be attributed to the date, time, place, and chamber it was grown, at a particular factory. For each stone sold, MiaDonna issues the supplier-provider certificate to the customer. As for precious metals, the company prioritizes suppliers providing recycled metals, traceable supply chains and with third-party certifications, such as Responsible Jewelry Council; and SCS Global Services Certifications Gold, and Platinum (recycled metals). Currently, approximately 92% of the company's suppliers are third-party certified by credible organizations and/or supply only lab-grown diamonds and gemstones to MiaDonna.
Management Comments	"MiaDonna is committed to providing conflict-free alternatives to traditional jewelry. We use recycled precious metals and lab-grown gemstones, ensuring no human rights violations in our supply chain. We work closely with our suppliers to maintain
