



DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Water Intensive Industries
SUMMARY OF ISSUE	As traditional Italian artisan bread producer, Pasticceria Filippia operates in an industry that is water intensive as water is a necessary part of its production process.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of the company's revenue consists of manufacturing of Christmas and Easter cakes. The company uses 1.114 liters of water for the production of 1 kg of cake.
IMPACT ON STAKEHOLDERS	As a water intensive industry, bread manufacturing poses risks such as water stress or depletion of local water sources if water use is not appropriately managed. The company uses water from the municipal water system to manufacture their bread. However, the production site is not located in a water stressed region.
IMPLEMENTED MGT PRACTICES	Pasticceria Filippi has registered a 13% reduction in their water consumption over the last three years, yet has not made an assessment related to water usage or management. The company has a monitoring plan in place and in 2023, will begin a Life Cycle analysis study of its products to analyze the impact of each product. The company targets to keep the ratio of liters of water to kilos of final product below 1.2.
