Disclosure Materials

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

B Lab's Public Complaints Process

Any party may submit a complaint about a current B Corp through B Lab's Public Complaint Process. Grounds for complaint include:

- Intentional misrepresentation of practices, policies, and/or claimed outcomes during the company's certification process
- 2) Breaches of the B Corp Community's core values as expressed in our Declaration of Interdependence

Disclosure Questionnaire Category: Firearms & Weapons

Topic	Sale of Airsoft Guns
Summary of Issue	Private Sports Shop sells airsoft guns which use compressed air to shoot biodegradable and plastic pellets. These products are intended to be used for sport only. Currently, the company only sells airsoft pistols recognized as categories 1 and 2 in France.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The airsoft gun sales represented approximately 0.39% of the company's revenue during their last Fiscal Year.
Impact on Stakeholders	Use of the product outside of its intended use may lead to injury of an individual.
Implemented Management Practices	Local laws set the minimum age to purchase this product at 18 years of age. Minors above the age of 9 may own this product with approval from their guardian and with a valid license from an approved sports federation.
	In addition, sites stating air guns with a power of 0,09 to 2 joules, can only be bought by 18 and above; the company is also working on an IT development to have a window popping up asking customers to certify they are 18 when they want to purchase such air guns.

Disclosure Questionnaire Category: Animal Products and Services
