SUMMARY OF ISSUE	As a dairy products company, Rodda's operates in an industry in which biodiversity impact is a material environmental issue.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Approximately 64% of supplier expenses come directly from animal farms. Rodda is a creamery in the UK that purchases milk from local farms in Cornwall and makes Cornish cream and butter.
IMPACT ON STAKEHOLDERS	Animal agriculture poses a risk to local ecosystems of flora and fauna as well as the potential degradation of farmed land.
IMPLEMENTED MGT PRACTICES	All Rodda's farmer suppliers must be Red Tractor certifed. Red Tractor is a UK Assurance standard that assesses farmers on their training, animal welfare practices, and food safety. The company is exploring biodiversity targets with their farmers through their annual senior management targets. One of these targets will be related to improving biodiversity on farm.

SUMMARY OF ISSUE	As a dairy products company, Rodda operates in an industry that is water intensive.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Approximately 64% of supplier expenses come directly from animal farms.
IMPACT ON STAKEHOLDERS	As a water intensive industry, animal agriculture poses risks such as water stress or depletion of local water sources if water use is not appropriately managed.
IMPLEMENTED MGT PRACTICES	The company does not currently monitor their water intensity in their supply chain. Many of the company farm suppliers capture and reuse water where possible. Water use through plate coolers is reused as wash down water or animal drinking water. Many also implement rainwater capture for animal drinking water. The company will be capturing on farm water usage through their carbon footprinting tool that will be piloted in 2022. Through this tool, best practice on minimizing water use will be shared throughout the wider supply group.

SUMMARY OF ISSUE	Rodda is a creamery in the UK that purchases milk from local farms in Cornwall and makes Cornish cream and butter. All of their farmer suppliers are Red Tractor reliant.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The company sources from a variety of family farms, the majority of which are grazing farms. They do not work with tethered farming systems.
IMPACT ON STAKEHOLDERS	The company only sources from farmers that are Red Tractor certified. Red Tractor Certification covers all types of practices related to animal welfare including housing and access to pasture, nutrition and drinking, health and safety, access to natural behaviours and training for farmers.
MPLEMENTED MGT PRACTICES	The company sources from Red Tractor Certified farmers and has the Rodda's Bespoke Standards. Rodda's carries out their own audits on their suppliers 2/3 times per year as part of their bespoke standards. They assess animal comfort, health and welfare, training, customer & public perception, mandatory standards, sustainability, and data information. Rodda's also implements targets on antibiotic reduction which is to be below the national average of 21mg/pcu. They are currently at an average of 16.5 mg/pcu
	They have not currently set any KPI's set on Animal Welfare but they do have targets on Antibiotic reduction and their target is to be below the National Average which is at 21 mg/pcu and they are at an average of 16.5 mg/pcu.
	The company carries out their own mini audits on their suppliers 2/3 times per year as part of their bespoke standards. They assess animal comfort, health and welfare, training, customer & public perception, mandatory standards, sustainability, and data information.



Environmentally Intensive Industries
Energy and Emissions Intensive Industries
As a dairy products company, Rodda operates in an industry in which energy and carbon emissions is a material environmental issue.
Approximately 64% of supplier expenses come directly from animal farms.
Animal agriculture is a major contributor to global carbon emissions.
In the company bespoke standard, they recommend that supplier farmers carry out a Carbon Footprint Audit. The company does not currently monitor their GHG emissions in their supply chain. Target is to have all farms reporting their GHG emissions within 36 months and to have built a reduction programme through the use of on farm workshops and sharing best practices. Support will be provided from external experts. Proposed target is for 3% reduction per annum across the supply group.
