Disclosure Materials

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Category: Other - Bankruptcy

Issue Date	November 2023
Topic	Voluntary Bankruptcy Protection Proceeding
Summary of Issue	In November 2023, one of United Repair Centre's entities at the time, Makers Unite B.V. , declared bankruptcy and ceased operations. The decision to stop operations was a direct result of the financial difficulties that the company faced which culminated in filing for bankruptcy.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Only Makers Unite B.V. filed for bankruptcy. The primary stakeholders affected were the entity's employees, suppliers, and investors. 2 employees faced job losses, a handful of suppliers experienced unpaid invoices.
Impact on Stakeholders	Companies that are in a state of insolvency are of concern to B Lab as it suggests the inability of the company to consider other stakeholders in its decision making except for creditors. Companies currently in bankruptcy (or currently under administration or filed for insolvency) are ineligible for B Corp certification. As Makers Unite B.V is no longer operational and is not in scope of this assessment, the company United Repair Centre was not impacted by this requirement.
Management Practices	In response to the bankruptcy filing, the company prioritized all key suppliers to ensure minimal harm within their network. To avoid additional layoffs, the company transferred several employees to URC to secure their positions. Following the bankruptcy, the company has undertaken a thorough review of the circumstances that led to this situation. For future operations, particularly under new entities or reorganized structures, the company plans to implement stricter financial oversight, improve risk management practices, and ensure better contingency planning.
