ISSUE DATE	Ongoing
TOPIC	Company sells goat milk products and sources >50% of supplier expenditure direct from farmers.
SUMMARY OF ISSUE	Alimentaria Caprina is a manufacturer and seller of goat milk products.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of the company revenue comes from the sale of animal products. The company sources from local suppliers, with 60% of their spending with suppliers that are within 80km of the company strategic center, and all suppliers located within 100 km.
IMPACT ON STAKEHOLDERS	The company sources from small scale underserved farmer suppliers. The average size of the goat herd is 150 goats.
IMPLEMENTED MGT PRACTICES	The goats are milked by hand and not by machine and the goats are free range on open pasture during the day and are brought inside at nighttime. The goats are not fed feed that contains GMOs. They only receive medicine as required for health issues, and are not given any other types of injections or medications. The company does not currently require any animal welfare certification from their suppliers but are interested in obtaining the Humane Certified Certification. The company does not have a supplier code of conduct that relates to animal welfare and has not currently set any KPIs for their suppliers on animal welfare. The company conducts regular visits to the suppliers, but these visits do not include a specific check on animal welfare, since the company has a close relationship with and a high level of trust for the suppliers. The company trusts them to treat the animals well, and the condition of the goats is checked generally during the visits. The company does not monitor and measure other impacts, such as water usage, biodiversity impacts, etc... of the suppliers.
