



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	The Grain Shed is a bakery and also a brewery company that earns a material amount of revenue from the manufacturing and sale of alcohol.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 9.82% of revenue was earned from the sale of alcohol.
IMPACT ON STAKEHOLDERS	Alcohol may have a negative impact on the health and well-being of individuals and their communities.
IMPLEMENTED MGT PRACTICES	The company is regulated and inspected by the Alcohol Tobacco Tax and Trade bureau and the Washington State Liquor Control Board. The company is in compliance with all regulations on the sale of alcohol in the jurisdictions where it operates. All employees are required to maintain a valid ""Mandatory Alcohol Server Training"" permit, a program which requires extensive training in how to not serve minors, how to avoid over-service, and how to deescalate situations involving alcohol.

SUMMARY OF ISSUE	As a brewery, The Grain Shed operates in an industry that is water intensive.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 9.82% revenue was earned from the sale of alcohol
IMPACT ON STAKEHOLDERS	As a water intensive industry, brewing poses risks such as water stress or depletion of local water sources if water use is not appropriately managed. The Grain Shed uses water from the Spokane Valley-Rathdrum Prairie aquifer, the city municipal water source, which currently is not recognized as a water stressed region.
IMPLEMENTED MGT PRACTICES	Company is aware of the importance of conscious use of water to avoid stress to its water cycle. The production was improved recently in order to recapture all of chilling water and use it as brewing water in the next batch. Company tracks their water usage on an annual basis for their entire operations as a brewery and bakery.
