Issue Date	2019, 2021, 2022, 2023
Topic	Employees presented claims for wrongful terminations and disagreements regarding the working hours.
Summary of Issue	One of the dismissed employees, whose skills did not meet the position expectations, brought a claim against the company for wrongful termination and moral harassment. The case was settled. Another three cases were related to the disagreements between the company and the employees regarding their transfer and working schedule. Two of these cases were settled and one was ruled against the company.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Over a five year period, Cleany has had 4 litigation cases related to labor topics. The paid value represented around 1% of the company's revenue in the reporting periods.
Impact on Stakeholders	Financial impact on employees.
