Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

## **B Corp Certification - Disclosure Questionnaire Documentation**

Environmentally Intensive Industries
Biodiversity Impact
As an agricultural company, Petalon Limited operates in an industry in which biodiversity impact is a material environmental issue.
Approximately 25% of Petalon's revenue comes from flowers grown directly by the company and 75% of revenue comes form imported flowers. Petalon controls 85 acres of land, of which approximately 20% is cultivated annually.
Agriculture poses a risk to local ecosystems of flora and fauna as well as the potential degradation of cultivated land.
"Petalon has adopted the forest garden principle, whereby a multitude of different plants are intermingled and grown together. This symbiosis leads to healthier soil, a more vibrant microbial community and also has advantages for weed exclusion. By pairing taller plants with ones that cover the ground lower down you provide a "nursery" for those taller plants in their infancy, without the risk of weeds crowding them out. Then when they are more developed they are able to grow up through that lower canopy.
Petalon leaves half of the land it controls to the local wildlife. On 20% of the land Petalon grows flowers using no-dig practices that mean the soil is never tilled and intead adds organic matter to the soil.
Petalon does not use pesticides or artificial fertilisers under any circumstances. The company keeps a mixed herd of animals on its farm who function as walking lawnmowers and fertilisers, grazing the weeds and enriching the soil. The company performs soil tests to monitor the improvement of the organic matter in the soil they have treated.
Note on animals: Company has 7 ducks, 13 sheep, 3 pigs and 2 cows. The company earns 0% annual revenue from anything to do with thier animals. They are there simply to help graze grass and weeds, eat pests such as slugs and fertilise the soil with their poo
