Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Clients in Controversial Industries
Summary of Issue	THINKHOUSE provides marketing and strategy services. From insights and campaign planning, social media, digital content marketing, email marketing / CRM, advertising, PR and event activation to their clients. The company has had clients operating in the alcohol industry on an ongoing basis over the last 5 years. The company's service to clients operating in the alcohol industry has included helping clients drive actionable positive change within their organization; encouraging investment in low & 0 alcohol products as responsible drinking and sustainability campaigns. The company's marketing service can be applied to companies operating in both controversial and non-controversial industries although they tailor their service to each client and industry.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In FY2022 clients operating in the alcohol industry represented 54.4% of the company's revenue.
Impact on Stakeholders	<p>Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.</p> <p>B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter."</p>
Implemented Management Practices	In Ireland, all alcohol related public-facing communication created by THINKHOUSE (on behalf of clients) is reviewed by the national body of Central Copy Clearance Ireland (CCCI or CopyClear), an independent pre-vetting service to help ensure the advertising of alcoholic brands in Ireland is "advertised responsibly and in accordance with the ASAI code". All employees demonstrate adherence to industry codes of

	<p>conduct by taking CCCI training and implementing guidance in their day-to-day work. Any new member of the business undertakes this training by way of induction.</p> <p>The company also abides by the Responsible Marketing Codes of Practice of their clients that operate in international markets. Beyond the industry codes of practice, THINKHOUSE works with its clients in the alcohol sector to work towards their externally published goals such as environmental stewardship, D&I and responsible drinking. It also undertakes ongoing initiatives that reinforces the importance of sustainability and 'business for good' amongst all of its client community, including those that operate in the controversial industries.</p> <p>THINKHOUSE has implemented a revised process for evaluating new business invitations. This ensures they only enter into bids, or contracts, that are aligned with the company values. They have declined multiple opportunities of work from sectors that do not align with their values (gambling, vaping, fossil fuel) with the aim of maximizing the agency's positive impact and minimizing the work it does in controversial sectors. The agency tracks this and reviews it annually. Sectors the agency is actively engaged in, growing and diversifying into, include; retail, food, culture, tourism and health with a specific focus on sustainability and driving positive behaviors for brands and businesses that care about people and planet.</p>
