- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Valiant Design is a brand strategy agency that has had clients in the Alcohol and Fossil Fuel Industry. Services offered to clients operating in the Alcohol industry included packaging design of bottles/labels or other marketing materials such as vineyard maps, advertising research and shop signs. Services to clients in the fossil fuel industry included website design and other marketing collateral, although they stopped working with these clients in 2022. Valiant Design can sell its services to clients in both controversial as well as non controversial industries, and the service is tailored to the client's needs.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the 2022 fiscal year clients from the fossil fuel industry represented <1% of the company's revenue and clients in the Alcohol Industry represented 10% of the company's revenue.
IMPACT ON STAKEHOLDERS	<p>Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.</p> <p>B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.</p>
MANAGEMENT PRACTICES	Valiant Design has a position to not work with tobacco companies, companies promoting pornography nor companies that risk human rights violations or damage the environment. New business enquiry is researched and discussed by the Leadership Team meeting as necessary to determine whether the potential client meets the company's stance on controversial industries and whether they can accept the client or project.
MANAGEMENT COMMENTS	"As a Leadership Team we take our responsibilities very seriously in accepting both clients and client projects. We fully understand the impact of working with companies where we have the potential to support their business growth. For that reason, our vetting process ensures we make considered and validated decisions that are in line with our values as a company and our B Corp commitment. As indicated by the figures, our work in B Corp's outlined controversial industries is a minimal part of our turnover."
