



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DATE	Biodiversity Impact
TOPIC	As an agricultural company, Wen Tang Tea Co. recognises that there are biodiversity risks connected to the production of agricultural crops.
SUMMARY OF ISSUE	Wen Tang Tea Co., owns and operates a tea farm. The tea tree is a perennial crop and once planted, can be harvested for up to 40 years.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The cultivated land that the company operates in 2.13 hectares. As the tea farm is located on a hillside, the cultivation rate is 70%.
IMPACT ON STAKEHOLDER(S)	Agriculture, particularly in cases where a single crop is cultivated at a time, poses a risk to local ecosystems of flora and fauna as well as the potential degradation of cultivated land. The clearing of natural habitat can result in the abundant decrease of local biodiversity and can also facilitate the entry of invasive alien species.
IMPLEMENTED MGT PRACTICES	<p>The company does not remove weeds and uses organic fertilizer. Pesticide is used in compliance with local regulation. Wild animals such as snakes and birds are allowed to enter freely into the farm as the farm is not fenced off. Human intervention is at a minimum as tea trees do not need to be frequently trimmed.</p> <p>After the Winter harvest every October, the next harvest does not occur until Spring time the following year during May. During these seven months, the farm is only active with workers for a one month period, in which they are fertilising and pruning the trees and no pesticide is sprayed.</p>
