Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Implemented Management Practices	IDG has policies which enables them to determine which projects/clients to work with and this is reviewed as a case-by-case basis. IDG also screens projects to ensure they fit with their values. As part of IDG's due diligence process, the following policies are applied in the screening process and in committing with the client: - Code of Business Standards - Environmental The company's Code of Business Standards ensures that any decision made by the company in choosing to work with a client is in line with the company's ethical principles, which includes to provide positive benefits and prevent harm.
