

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	As an alcohol beverage wholesaler, North South Wines operates in an industry in which biodiversity impact is a material environmental issue.
SIZE/SCOPE OF ISSUE	which biodiversity impact is a material environmental issue.
IMPACT ON STAKEHOLDERS	North South Wines (NSW) is a wine distributor/importer. They sell business to business to On and Off Trade customers. They import wine from around the world. The production of wine is a agricultural process and effects local biodiversity to NSW suppliers who grow their own grapes. The loss of biodiversity could be from using land for agriculture affecting local fauna and flora, as well as impacting soil biodiversity. NSW does not produce any wine, only imports and sells it within the UK, they do screen their suppliers on their impact on Biodiversity.
IMPLEMENTED MGT PRACTICES	NSW impact on biodiversity is minimal as they use a serviced office, they have put in place an Environmental Management System to monitor their impacts. They collect information from all their significant suppliers on their biodiversity policies and their targets for improvements. They screen all new suppliers on their biodiversity policies and targets. They have targets for all their significant suppliers to have environmental or social certifications by 2025. They have launched a supplier newsletter to share information and techniques in sustainability areas to improve all their suppliers impacts.
MANAGEMENT COMMENTS	North South Wines works closely with our suppliers to ensure their impact on Biodiversity is understood and reduced. All new suppliers are screened on their Biodiversity practices.

SUMMARY OF ISSUE	As a Alcohol beverage company, New South Wines operates in an industry that is water intensive.
SIZE/SCOPE OF ISSUE	More than 80% of supplier expenses come directly from winery farms.
IMPACT ON STAKEHOLDERS	As a water intensive industry, wine agriculture poses risks such as water stress or depletion of local water sources if water use is not appropriately managed.
RESOLUTION	
IMPLEMENTED MGT PRACTICES	Most of NSW's significant suppliers are from medium to high water stress regions. The water source is from the municipality and ground water (water boring). As for the supplier's water intensity I.e. Litre/unit of product, only some of suppliers track them and conduct an assessment on how it compares with others in their industry. This is also backed by the certification received such as Certified Sustainable Wine of Chile, Sustainable Wine Australia certified, Integrated Production of Wine (IPW) environmental sustainability scheme certified, and Equalitas certification which measures water usage. NSW claims that the remainder of suppliers will strive to track their water intensity in the near future.
REPORT	
MANAGEMENT COMMENTS	North South wines works closely with their suppliers on their water reduction practices. Not all suppliers currently track water intensity against industry benchmarks, they all track usage and have good practices in place to reduce water use and are working towards tracking water intensity in the near future. All new suppliers are screend on the water reduction practices.
