## Disclosure Materials

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

<b>Summary of Issue</b>	<p>Fonk's Backwaren AG failed 4 out of a total of 5 food safety inspections conducted between on 04.05.2020 and 04.07.2023 by the Federal Agency for the Safety of the Food Chain (FASFC) in Belgium and was required to pay penalty for failing to comply with food safety measures. See noncompliance issues below:</p> <ul style="list-style-type: none"> <li>- Display of expired food items for sale on their counters / shelves.</li> <li>- Poor hygiene and failure to communicate food allergens as required</li> <li>- Failure to comply with the required refrigeration temperatures for specific food items</li> </ul>
<b>Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)</b>	<p>Total amount paid by the company as penalty = € 1. 435 Representing 0,017% of the company's total earned revenues</p>
<b>Impact on Stakeholders</b>	Consumers may encounter health risks due to potentially unsafe food practices, impacting their trust and satisfaction with the company.
<b>Resolution</b>	The case was resolved through a penalty paid by the company to the Federal Agency for the Safety of the Food Chain ( FASFC) in Belgium.
<b>Implemented Management Practices</b>	<p>The company has implemented the following management practices and policies:</p> <ul style="list-style-type: none"> <li>- Training of staff to ensure the correct handling of food is maintained on topics such as proper storage, checking expiration dates, and hygiene measures</li> <li>- Upgrade and regular maintenance of cooling equipment at their facilities.</li> <li>- Additional self-inspections conducted by the district manager</li> </ul>
<b>Management Comments</b>	The company has taken a number of steps to address the DQ issue and reduce the risk of similar occurrences in the future. These steps include staff training, maintenance of cooling



	equipment, self-inspections by the district management, and a change of cooling technician. The company will continue to monitor the situation and take additional measures as needed
