Issue Date	Ongoing
Topic	The company works with data collection vendors that operate in conflict zones.
Summary of Issue	Altai is a consultancy that works with international organizations like the World Bank, the United Nations, with bilateral donors (USAID, FCDO, GIZ, etc.), with foundations and NGOs around the globe to provide research and create data driven projects that focus on the developing world. As such, the company has worked with third party data collectors in Afghanistan, Libya, Iraq, Somalia and Ethiopia.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Up to 20% of Altai's data collection officers work in areas that qualify as conflict zones as per the World Bank List of Fragile and Conflict - Affected Situations. 20% of their data collection happens via phone and 80% happens in person.
Impact on Stakeholder(s)	Altai has a zero risk policy for its staff, its partners and its data collection vendors. The company states that risk to the data collection officers is low as the majority of data collection is carried out either i) in areas (part of conflict-affected countries) where no conflict is happening or ii) by phone. In case Altai evaluates that in person data collection could result in risk for data collection officers, Altai immediately amends its research protocols so that data collection gets postponed, or takes place by phone or if not possible, simply cancels the corresponding project components
Implemented Management Practices	The company formalises their intervention by specifying business conducts and making sure they comply with the requirements of their NGO clients. All of their vendors sign and obey their code of ethics. All their vendors also sign and follow their data collection protocols that are in line with GDPR. They all have their own insurance policies. The company also contracts insurance for them on a case by case basis.
Other Management Comments	We are not focusing on "conflict" topics but rather on "development" issues. We are not conducting emergency work,
