Topic	Clients in Controversial Industries
Summary of Issue	Roadnight Taylor provides consulting services focused on connecting low-carbon technologies to the grid and decarbonisation. The company has had clients in controversial industries such as Nuclear Power or Hazardous Materials, Fossil-Fuel (non coal/oil sand) & Water Utilities in the last 5 years. The nature of the company's services with clients in these industries has been related to decarbonising, helping clients develop/acquire renewable energy projects and feasibility studies. All of the company's services can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The total revenue derived from the consulting services provided to the companies in the fossil-fuel (non-coal/oil sand) industry represented about 17% of their revenue in the last financial year, 2023. The last service provided to clients in the nuclear power or hazardous materials and water utilities industries were in the year of 2022 and together represented 2% of their revenue for the financial year of 2022.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company had stopped working with clients in the Nuclear Power or Hazardous Materials industry in 2022 and does not intend to work with them in the future.

	Roadnight Taylor has implemented an onboarding process for potential new clients. This process ensures that Roadnight Taylor is provided with information on what the prospective client requires. At this stage, the Roadnight Taylor is able to carefully select whether they wish to continue with onboarding the client, or should the client not align with its values and mission, Roadnight Taylor would not pursue.
