

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DATE	January 2018
TOPIC	Significant layoffs due to loss of revenue.
SUMMARY OF ISSUE	Due to revenue impacts from a state budget delay, West Arete laid off members of its workforce.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	3 workers were laid off, representing approximately 33% of West Arete's employees at that time.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	"The layoffs occurred because the majority of the company's revenue at the time came from Pennsylvania universities and businesses, and the state government went through a crisis where a state budget was not passed for 9 months. This resulted in universities and businesses not receiving critical funding for operations, which in turn resulted in a freeze on spending and paying invoices to vendors including West Arete. The 3 employees were employed until the last possible date. The company wanted to provide every possible chance to keep them. Management personally took on the administrative duties via overtime, and maximised the amount of debt the company could take on, in order to preserve as many jobs as possible. The company was not able to provide additional benefits or severance past the last day of employment for affected workers. It worked hard to create recommendations, networking, introductions, and leads for them in terms of new positions. Ultimately, this ensured that each person landed in a good place, and the company remains on good terms with all of them."
