Disclosure Questionnaire Category: Industries at Risk of Human Rights Violations

Topic	Forced labor and human rights violations are recognized as material issues in the jewelry industry.
Summary of Issue	Rachel Boston Jewellery is a London-based fine jewellery brand founded by Rachel Boston, known for its modern Art Deco-inspired engagement rings, bespoke bridal jewellery and gemstones. that earns a material amount of revenue from raw materials whose supply chain carries risks of human rights violations which includes jewelry & precious metals.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	100% of Rachel Boston Limited revenue comes from the sale of jewelry made from precious metals and gemstones.
Impact on Stakeholder(s)	The global jewelry & precious metals industry has a history of forced and child labor, which subjects workers to poor working conditions, low wages, and puts children at risk for human trafficking.
Implemented Management Practices	<ul style="list-style-type: none">- Single Mine Origin (SMO) Gold <p>Rachel Boston Jewellery offers Single Mine Origin gold, which is fully traceable to a single vetted mine. According to the company, these mines are assessed against standards relating to environmental impact, community investment, and workplace support for women, helping to improve transparency and accountability in gold sourcing.</p> <ul style="list-style-type: none">- Fairtrade Gold <p>Rachel Boston offers Fairtrade Gold as an option for bespoke jewellery commissions. The company states that Fairtrade-certified gold supports fair wages, safer working conditions, community development initiatives, and social infrastructure such as schools and healthcare within mining communities. The brand also notes that it does not profit additionally from the use of Fairtrade metal.</p> <ul style="list-style-type: none">- Ethically Sourced Diamonds and Gemstones



The company states that all natural diamonds are sourced from trusted suppliers committed to eliminating conflict diamonds and complying with the Kimberley Process. Diamonds are certified by recognised laboratories including GIA, AGS, IGI, and IGR-Global. Rachel Boston also encourages the reuse of heirloom and recycled diamonds to help reduce environmental impact.

- Recycled Precious Metals

Rachel Boston states that 100% of their cast metal gold and platinum used in production are recycled or reclaimed precious metals refined from existing jewellery and scrap materials. The company explains that recycled metals are chemically identical to newly mined metals while helping reduce mining-related environmental and social impacts. The workshop also recycles its own scrap metal wherever possible.

- Sustainable Production Practices

The brand primarily operates on a made-to-order basis to minimise overproduction and waste. All jewellery is handcrafted in the United Kingdom using local workshops and craftspeople, particularly within London's Hatton Garden jewellery district.

- Packaging and Environmental Practices

Rachel Boston uses biodegradable mailers, FSC-certified shipping boxes, recyclable packaging materials, and vegan leather jewellery boxes as part of its broader effort to reduce environmental impact.
