Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Industries at risk for human rights violations

Topic	Company sources metal precious and gemstones
Summary of Issue	La Luce is a jewelry retailer and manufacturer whose products utilize precious metals and precious gemstones. These raw materials could be considered conflict minerals and pose a potential human rights risk.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Approximately 50% of the company's Cost of Goods Sold comes from raw materials that would be considered a high risk for human rights violations.
Impact on Stakeholders	The use of precious metals and gemstones poses a human rights risk due to the possibility that they are sourced from conflict-affected and high risk areas, where they may be used to finance conflict and/or be associated with human rights abuses in the supply chain.
Implemented Management Practices	La Luce has a code of conduct applicable and signed by all their suppliers that establishes minimum expectations regarding social and environmental standards. The company also has a supplier policy for Conflict Minerals that lists specific tasks to be carried out by the vendors to ascertain that their goods are conflict-free. In addition to that, the company sources part of their materials from credible third party certified suppliers: 100% of gold and silver is Fairmined certified; 100% of diamonds used are either Ocean Diamonds, Canadamark certified or Lab-grown diamonds. La luce maintains a strong first hand relationship with all the suppliers, is involved in their supply chain, and shares openly their practices. Although La luce hasn't been able to visit the mines and cutting facilities, yet, they have witnessed the same experience made by other colleagues.
