Disclosure Questionnaire Category: Other - Clients in Controversial Industries

Topic	Clients in Controversial Industries
Summary of Issue	Deecon Consulting Limited is a management consultancy based in the UK that has had clients operating in the Defense, Fossil Fuels (other) and Water Utility industries over the last 5 years. Services to these industries included Value for Money Assessment, commercial support services, supplier management, property and logistics strategy setting among others; all services that can be sold to both clients in controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The client operating in the Defense industry was through a one-off engagement in FY2023 representing 7.53% of the company's revenue. Deecon no longer serves this client and industry. Clients operating in the Fossil Fuel (other) industry represent 21.43% of the company's current year revenue. Clients in the Water Utilities industry represent 31.68% of the company's current FY revenue.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company does not currently have a position on working with clients in controversial industries. Deecon Consulting evaluates each project against their ESG principles prior to bidding to ensure that the project will not generate negative impact. All clients of Deecon Consulting are assessed through desktop research and independent market



	analysis, including in person meeting by their Senior Management Team, to ensure that the services provided by Deecon Consulting are not used for harming people and/or the environment.
