SUMMARY OF ISSUE	Hawksmoor is a restaurant and bar that earns a material amount of revenue from the sale of alcohol.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 30% of Hawksmoor's revenue was earned from the sale of alcohol.
IMPACT ON STAKEHOLDERS	Alcohol may have a negative impact on the health and well-being of individuals and their communities,
IMPLEMENTED MGT PRACTICES	Hawksmoor complies with all local regulations and laws with regards to the serving of alcohol. Alcohol licensing paperwork is displayed and the company operates a 'challenge 25' policy towards service of alcohol in the restaurants. All Designated Premises Supervisors are fully trained in responsible service of alcohol and license holders have all passed licensing, which includes exam questions on the sale and supply of alcohol to young people as well as responsible consumption. All relevant employees receive training on responsible service of alcohol during the company induction. Teams are briefed of the dangers of over-serving and the illegality of serving minors. There is a senior manager on premises at all times to ensure there is supervision of team members who serve alcohol. Employees receive additional briefings of the company policy during busy periods such as the run up to Christmas when there is more pre and post meal drinking happening in the restaurants.

TOPIC	Hawksmoor is a restaurant and sources >50% of their supplier expenses from animal farms.
SUMMARY OF ISSUE	Hawksmoor source animal products (beef, pork, fish, seafood, dairy and eggs) from British higher welfare farms and suppliers. For example, cattle are raised outdoors (they're only brought into barns if the grass isn't fit for grazing in colder months) and are fed a diet of foraged grass and hay. Eggs are sourced from chickens raised on organic or free range farms. Fish are wild-caught or sourced from farms.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Hawksmoor source all animal products from 650 British farms and suppliers. Beef has an average herd size of 10 to 300 (depending on farm), other animal herd sizes can range from 20 to 600.
IMPACT ON STAKEHOLDERS	All cattle farmers are required to comply with the Hawksmoor Beef Standards which sets out requirements around how the cattle are raised (taking in genetics, animal welfare, feed, environment). The procurement team works directly with all the cattle farms in the supply chain to support them and ensure standards are met through regular audits. For other animal products, the company sets standards in their Sustainability and Environmental Procurement Policy: Wild-caught fish: sourcing fish from FAO Fishing Areas or stocks within these areas, that have been caught using the most selective fishing methods e.g. hand or pole line, traps. Additionally no fish is sourced whilst in their spawning season. Farmed fish: sourcing fish from a recognised welfare scheme such as organic, Aquaculture Stewardship Council, Freedom Foods, Global GAP Dairy and eggs: sourcing from high welfare farms such as free-range or organic.
IMPLEMENTED MGT PRACTICES	Hawksmoor has set the highest welfare standards across all animal produce. Hawksmoor has been awarded a three-star rating (the highest rating) for the past 12-years by the Sustainable Restaurant Association, who audit all protein sourcing. IMPACT ON STAKEHOLDERS	Animal agriculture poses a risk to local ecosystems of flora and fauna as well as the potential degradation of farmed land.
