

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	"TEVA operates a restaurant that earn a material amount of revenue from the sale of alcohol.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 9.7% of revenue was earned from the sale of alcohol.
IMPACT ON STAKEHOLDERS	Alcohol may have a negative impact on the health and well-being of individuals and their communities.
IMPLEMENTED MGT PRACTICES	TEVA is a vegan restaurant that has a wine/cocktail bar. Its main focus is on plant-based food. It does not attract young people or people who just come to drink alcohol. Its customers come for lunch or dinner and can have a drink during the meal. In more than 5 years of operation, the company has not had any problems with any customer leaving TEVA drunk. The company also does not attract young people under the age of 18 due to the restaurant's profile. If young people go there, they are typically accompanied by their parents or adults. Regardless of this, if in doubt, the company asks for its customers' age before serving alcohol. Alcohol sale to minors is prohibited and the company has visible warning signs of this in place.
OTHER MANAGEMENT COMMENTS	We know alcohol is not good for the health of our client but we believe it is important for our purpose to sell it in order to attract people that otherwise would go to another restaurant not B corp, not plant based. When we created Teva we wanted to be different from others vegan restaurants. We created it in order to change peoples behaviour and to eat less animals in general. This is good for the health and environment. It is important for us to have alcoholic drinks so non vegan people can come aswell and non vegans are the majority of our clients. That why we believe in the impact we are making in Rio de Janeiro.
