TOPIC	Water Intensive Industries
SUMMARY OF ISSUE	As a distiller, Nc'nean Distillery operates in an industry that is water intensive.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 84% of Nc'nean Distillery revenue was earned from the sale of alcohol. Water is needed for both the production of whisky and to cool the alcohol vapours as they come out of the distillation process. Water usage is essential to the process, and the majority of it (130 litres/per minute) is required to cool the spirit. The company has two condensers, which can require up to 260 litres per minute (130 liters/per minute per condenser). The company stills run for 8 hours a day 5 days a week.
IMPACT ON STAKEHOLDERS	As a water intensive industry, distilling poses risks such as water stress or depletion of local water sources if water use is not appropriately managed. The company have a private water source which is dedicated entirely to distillery use. They are not located in a water stressed region.

IMPLEMENTED MGT PRACTICES

"They have designed the condensers (the equipment that cools the spirit that comes off the stills) to be on a closed loop system so that the same volume of water is re-used over and over. This reduces the water intensity taking their water footprint down to an average of 36 litres of water per litre of alcohol produced. Furthermore, they have environmental policies relating to water, which set out that they have to continually monitor usage and at least annually assess ways that they can improve their water efficiency.

They have also conducted an assessment, based on litres of water per litre of pure alcohol produced, but the company adds that this research is not easily comparable because water usage and calculation methods are not routinely published by distilleries in the industry. Research from an international industry body indicates that distillery usage can range between 5 – 135 litres per litre of finished product. The company usage under this methodology is 17 litres per litre of finished product. The Scotch Whisky Association are piloting a new stewardship scheme for water usage which is aimed to encourage a significant reduction in water usage to below 25 litres/LPA. This scheme should encourage more visibility about water use in the industry"

IMPLEMENTED MGT PRACTICES

"The company complies with all of the regulations and laws related to the sale of alcohol in the jurisdictions where they operate.

They follow industry best practice for alcohol marketing, such as defined by the Portman Group. This includes showing the number of UK units on the bottle, and the recommended wording "The UK Chief medical officer recommends adults do not regularly drink more than 14 units per week. Drink responsibly." on every bottle that they sell.

They have an age gateway on their website which requires people to identify as over 18. In their bar and for tours they adopt the 'challenge 25' policy which requires ID verification for the consumption and sale of alcohol to anyone who looks under 25 (the legal age for drinking in the UK is 18 so this is very conservative)."
