Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Others - Clients in Controversial Issues

Topic	The company serves clients in Prisons, Zoos, Casinos, Nuclear, Fossil Fuels and Energy Industries, and Cannabis Industry.
Summary of Issue	Chandos Construction services to clients in industries considered controversial by B Lab. In the last 5 years, the company provided improvement and building infrastructure in prison facilities in Canada, accredited zoos, recreational cannabis-related companies, casinos, energy companies that operate in the fossil fuel industry, and an organization in the nuclear industry (focused on Clean Energy and Health Sciences). Those industries are considered Controversial by B Lab.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	2022 revenue in percentage by controversial industry: Nuclear 6.84% Casinos: 3.04% Fossil Fuels: 2.91% Zoos: 0.53% Prisons: 0.49% Cannabis: 0.03%
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter. In December 2021, B Lab's Standards Advisory Council met and made a decision regarding the eligibility for B Corp Certification of companies supplying to prisons/detention centers (B Lab's Risk Standards for Prison Industry and Labor). According to the new standards, Certified B Corps supplying to prisons/detention centers and/or utilizing prison/detention center labor will have a grace period of one recertification cycle (i.e., greater than or equal to 3 years) to implement the

	additional requirements outlined on the updated standards. Therefore, during Chandos Construction's next recertification process, the company will have to meet all risk requirements. B Lab has flagged Clients in Controversial industries as a material issue and new standards will be created to address possible risks related to this matter. Should the Standards Advisory Council determine specific performance requirements for companies in this industry, Chandos Construction would be required to meet these standards by a future recertification date.
